One of the enjoyable things that I did recently was to work with Tim Bond to produce a number of short filmed vignettes on therapeutic issues (accessible through the 4th edition of Standards and Ethics in Counselling in Action). I spearheaded the BACP curricula for e-therapy training and training trainers to deliver it.
